ROADS AND MARKETS; HENDERSON COUNTY PETITIONS THE SOUTH CAROLINA LEGISLATURE - BY ALEXIA JONES HELSLEY

Historically, Western North Carolina has experienced a sense of isolation. Natural obstacles cut off the west from the east making transportation between the two areas difficult. As a result, almost all western trade was either with Virginia or South Carolina. The Buncombe Turnpike, completed in 1828, gave an impetus to western trade. This road ran from Saluda Gap by way of Flat Rock and Hendersonville through Asheville to the Ten-At the South Carolina line, the nessee line. Buncombe Turnplke connected with the South Carolina State Road linking the mountains with Greenville, Columbia, and Charleston, South The charter issued the Buncombe Carolina. Turnpike was later taken over by the Asheville and Greenville Plank Road.

Despite these advances in transportation between Western North Carolina and the South Carolina Up-country, residents of Henderson County continued to seek improvements in the In 1858 concerned citizens in road system. Henderson County petitioned the South Carolina Legislature for assistance. In fact, two petitions from Henderson County residents were submitted to the South Carolina House of Representatives by Benjamin F. Perry, Representative from Greenville District. The first petition was introduced on 26 November 1858 and the second on 29 November 1858. petitions, along with several from concerned citizens of Greenville District, were referred to the Committee on Roads, Bridges, and Ferries. The Committee on Roads, Bridges, and Ferries declined to consider the merits of the petitions as the Commissioners of Roads of Greenville District had not recommended the opening of the road requested.

Therefore, these petitions represent an unsuccessful attempt by certain residents of Henderson County to lobby the South Carolina Legislature. Nevertheless, the petitions are of interest both for their content and for the list As the petitions are virtually of signers. duplicates, only the text of one is printed here, although both sets of signers are listed below. The original spelling as found on the petition is maintained. It is worthy of note that all sighers were capable of writing their names and that no marks in lieu of legal signatures appear The text of the petition on these petitions. follows:

"We the undersigned citizens of the State of North Carolina would most respectfully represent to your honorable bodies that our most important market for all the produce of our farms, dairies, pastures, and orchards is at the Town of Greenville in the State of South Carolina and therefore we feel the deepest interest in the improvements in the public roads from this region of country to that town and are very anxious for the relocation of the road from Cleveland Bridge on Middle Saluda by McCoys Bridge and Westly Phillips to Mrs. R. 5. C. Fosters; and from Mrs. Fosters we want a new road on the ridge running south west of Mr. Saml G. McClannahans, and Col. E. L. lrvins residences crossing Long Branch near its mouth and running thence on the South West side of Reedy River on the nearest and best ground to the Greenville Railroad Depot. therefore most cordially join in the petition of the people of Greenville and Pickens Districts So. Ca., to your honorable bodies to pass an art to appoint a commission to relocate and establish the public road as above set forth."


