### “Burned County Research”

The speaker, better known to us as “Jo”, is a member of our own chapter. She has done much research and can give us many hints on where to find traces of our ancestors when the county has no records of the time period in which those elusive ancestors lived.

**CAN ONE OF YOU HELP A REED FAMILY RESEARCHER???** It will probably have to be one who has copies of the newsletters before we started the quarterly journals. **Debby James, 8600-110 Olde Colony Tr., Knoxville, TN 37923** relates: “I am researching my grandmother’s father’s father’s family **REED**. My GM: Mary Frances Reed Moss; her father: Braddock Reed m. Alice Bell Bundy (Smith Co. TN); his father: George Reed m. Frankie Beasley. I found the enclosed sheet of paper in REED folder and am sure there is a connection. My George Reed was b. NC. ca 1810. Lived next to or near an Archibald Reed, James, Mary Reeds in 1850 census (& Mary living w/ Nancy as above). The Knoxville Archives only had this one sheet, “REED FAMILY INFORMATION”, copied from Old REED family Bible printed 1829.” Lists Archibald Reed b. Sep 20 - 1768 among the many births. This was the back sheet of a Greenville Chapter SCGS newsletter sent to Knoxville Knox Co Public Library. The sheet stated that the info was from James Reid--family known to be related to the Arch Reed family and also to some Reid who had son Samuel Reid b- Oct 1798 and also Wm and James and Robert. Then it stated “Continued next issue.”

Would some of you look through your newsletters and see if you can find it and the **next** issue where it was to be continued? Thanks a heap!!!
