She suggested using church records, reconstructing a neighborhood for that time period, and other records of the area that might reveal genealogical information. The president appointed Butch Morton, Franklin Spearman and Dorothy Hawkins to serve on the nominating committee to secure officers for 1998.

During the meeting, some expressed a desire to reprint some of the cemetery books. Brent Holcombe has copies of Books 1 and 5 for sale. No committee was appointed to investigate the cost or feasibility of reprinting one of these books at this time. The meeting adjourned.
