He recently completed "A Town Springs Forth – the Story of Williamston, SC", which will be published in January. Mr. Welborn will speak on the history of Williamston and give us a preview of his new book, which is a compilation of history, photographs, maps and yarns of Williamston collected from a multitude of individuals plus reasearch by the author.
