CASE'S CORNER

BRANCHING OUT INTO ADDITIONAL RESOURCES: Probate Records

For the past couple of years, we've studied the censuses indepth and, as we know, they are an invaluable source of information on our ancestors. In fact, they are often the starting point in our research (after talking to any relatives that might have information to help get us started).

Once we've searched the census, there are many other resources that can give us additional information. These include court, military, church, immigration, vital, and land records. For the next few months, we'll investigate some of these records to see how they can help us.

One of the primary sources of valuable information is the probate record. In South Carolina, probate records can consist of estate records, guardianship records, and lunacy records. Probably the most commonly used are the estate records. If the individual has died testate (with a will), this can be a real gold mine for the researcher, as the will frequently mentions family members by name and gives their relationship to the deceased. Executors or administrators of the estate are frequently related to the deceased individual and witnesses to the will are generally close, trusted family members, friends and/or neighbors. Note all of these names, as there will be a relationship of some sort. If you run into a brick wall, an investigation of some of these names may yield additional information on your ancestor.

Studying the estate inventory will give you a picture of how your ancestor lived, as well as his/her level of prosperity. Slaves are generally listed by name in the inventory and often mothers are listed with their children. Thus, the estate record is also an invaluable resource for those doing African-American research.

Even if your ancestor died intestate (without a will), you can study the documents in the estate records to see how the estate was divided and who the purchasers were. These will usually be relatives, in-laws and neighbors. Note these names, as they are generally important people in your ancestor's life.

If your male ancestor died leaving young children behind, a guardian would frequently be appointed to look after their interests. This was often done even if the mother was still living and the children were living with her. Not always, but in many cases, the guardian was an uncle of the children. Frequently, guardianship would be formally and legally established if both parents had died and the child/children went to live with the guardian. Guardianship records can thus also be used to establish a relationship. Both estate

records and guardianship records may also give you the date that your deceased relative died.

Sometimes, in the process of settling an estate, family members who had moved to a distant location would be named (especially if someone living in the area where the estate of the deceased was probated was named to look after the distant family member's interests). This is another great way to track movements of your ancestors.

In some cases, an estate might be very difficult to settle due to challenges to the will, disputes over the handling of the estate, etc. In those cases, in South Carolina, the settlement of the estate might be referred to Equity Court. The Equity Courts handled difficult cases that were not easily settled in other courts. These cases frequently took years to settle and would often name many individuals and where they were living, making them yet another resource for tracking your ancestors' movements. These courts were set up in each South Carolina circuit court district beginning in 1791. (Note: Greenville County was part of Washington District until it was disbanded in 1800 and many Washington District Equity Court records are now part of Laurens District records. Check Laurens District records if you do not find pertinent information in separate Washington District records).

Most probate records, nationwide, can be located at state archives, county courthouses, local historical societies and/or local public libraries with genealogical collections. Microfilmed probate records for some counties are also available by order from the LDS Library in Salt Lake City and can be ordered through your local LDS Library. In Greenville, the LDS library is located on Boiling Springs Road. The South Carolina Room in the Hughes Main Library, Greenville County Library System, can also order LDS microfilm.

Greenville County Probate records are located at the Greenville County Probate Court office at County Square, as well as in the South Carolina Room, Hughes Main Library. The South Carolina Room also has probate records for other Upstate counties, including Spartanburg, Pickens, Oconee, Anderson, etc. In addition, the South Carolina State Archives has digital images of the "South Carolina Will Transcripts, 1782-1855" at its On-Line Records Index site. These (as well as other records) can be searched at: http://www.archivesindex.sc.gov/.

Reedy River Baptist Church

Reedy River Baptist Church, located at 871 N. Hwy 25 Bypass, Greenville, SC, was established by upcountry pioneers sometime prior to 1789 as Head of Enoree Baptist Society. In 1791 it had forty-seven members. The church grew, ordaining and licensing numerous ministers, both white and men of color.

At least four Revolutionary War veterans who became Baptist preachers were associated with the church: Robert Benson, who was born February 1762 in Virginia, the son of Prue and Elizabeth Benson; William McClanahan who was born 23 February 1732 in Westmoreland County, Virginia, the son of William McClanahan and Martha Smith, and husband of Mary Marshall (the aunt of John Marshall, later Chief Justice); John Tubb, who was born 6 August 1758 in Orange County, North Carolina, the son of William Tubb and Elizabeth Tabor; and Joseph Willis, who was born a slave to a slave mother and plantation owner in Bladen County, NC. Joseph Willis, while still legally a slave but given wide freedom of movement by his owner, fought under Francis Marion, the Swamp Fox, in South Carolina in the American Revolution. It has always been a great source of pride among his descendants that he was one of Marion's men.

The early church members were mostly small landowners, as well as a few well-to-do landowners who owned slaves, who were also members. Around 1819, the church moved to its present location and in 1820 John Salmon gave two acres "lying on the waters of reedy river near where the old meeting house now stands for the full and proper use and benefit of the said church."

Early pastors of note include Abraham Hargess, William King, Isaac Lemons, Samuel Gibson, and James C. Furman. The church cemetery was established in the early 1800's and is significant in that it contains the graves of founders of the area, slaves, 40 Confederate soldiers and veterans, 1 Spanish American War veteran, 14 World War I veterans, and over 40 World War II veterans. Today it is maintained through a Cemetery Trust established in 1977.

Known as the "Mother of Churches", Reedy River sponsored the establishment of several churches throughout the area, including Shoals Creek, Tyger, Rock Springs, Double Springs, Clear Springs, Ebenezer, Berea, Enoree, Forestville, First Baptist of Travelers Rest, Clearview, and Mt. Sinai.

Reedy River Baptist Church, in celebration of its 220th anniversary, has several historical programs planned for the public. On September 20th, the Sunday morning program was "The mission of Reedy River Baptist Church demonstrated by the life of Joseph Willis: former slave, Revolutionary War Veteran, Baptist preacher, and missionary", by historian Scot Withrow.

Wednesday, October 7 will see the "Dedication of Memorial Marker for William McClanahan, Revolutionary War Veteran & Baptist Preacher" presented by the Sons of the American Revolution. A special service will be held at 7:00 PM that night with descendants of Rev. McClanahan, Larry D. McClanahan, former President General of the Sons of the American Revolution, and Ed Butler, President General of the Sons of the American Revolution, as guest speakers. The public is invited.
